

HANSON COUNTY DRAINAGE BOARD
MINUTES OF PROCEEDINGS
Tuesday, September 7, 2021

Chairman Kjetland called the meeting of the Hanson County Drainage Board to order on Tuesday, September 7, 2021 with members Bumgardner, Fox, Schoenrock and Waldera present. The Drainage Administrator was also present.

Motion Waldera, seconded by Fox to approve the agenda.

Motion Schoenrock, seconded by Waldera to approve the August 17th meeting minutes.

No citizens input.

Motion Fox, seconded by Schoenrock to approve a permit for Ed Engelmeyer to clean an existing ditch in the NE4 of 9-101-58. Motion carried.

Motion Waldera, seconded by Schoenrock to approve a permit for Todd Mabee to tile in the S2 of 15-104-59 as the following conditions have been met: Project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; erosion is minimal; water quality and supply will not be impacted; ag production will increase; environmental quality will improve; aesthetics will be maintained; fish and wildlife values will not be affected; receiving watercourse does have sufficient capacity; drainage is a reasonable improvement; drainage is a reasonable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow will be better. Motion carried.

Motion Fox, seconded by Bumgardner to approve a permit for James Paulson to back slope a ditch into the field in section 23-104-58. All voted aye, motion carried.

Motion Schoenrock, seconded by Fox to approve a permit for Danny Roth to fill in a wash out and install a 24" drain tile in the NE4 of 5-101-58 as the following conditions have been met: Project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; erosion will be reduced; water quality and supply will not be impacted; ag production will increase; environmental quality will improve; aesthetics will be maintained; fish and wildlife values will not be affected; receiving watercourse does have sufficient capacity; drainage is a reasonable improvement; drainage is a reasonable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow is reasonable. Motion carried.

Motion Waldera, seconded by Bumgardner to approve two permits for Jim Ness to fill in stock dams in section 6-104-58. All voted aye, motion carried.

Motion Fox, seconded by Waldera to approve a permit for Bannwarth Ag to clean a road ditch and back slope towards the trees in section 22-104-59. All voted aye, motion carried.

Motion Waldera, seconded by Bumgardner to approve a permit for Jim Bannwarth to clean an existing drainage ditch in section 14-104-59. All voted aye, motion carried.

Motion Schoenrock, seconded by Bumgardner to table a permit for Bannwarth Ag to clean an existing ditch in section 14-104-59. All voted aye, motion carried.

A list of permits approved by the Drainage Administrator was presented to the Board for review.

Clarification that the Hwy Superintendent should be the person to contact regarding any county road ditch that needs to be cleaned so the Hwy Dept. can take care of this as it is the county's responsibility to maintain the right-of-way.

Penalties for drainage done without permits was discussed.

As there was no further business before the Board, a motion was made by Waldera, seconded by Fox to adjourn meeting. All voted aye, motion carried.
