

ORDINANCE NO. 1

AN ORDINANCE REPEALING EXISTING COUNTY COMMISSIONERS' DISTRICT BOUNDARIES AND ESTABLISHING NEW BOUNDARIES.

BE IT ORDAINED BY HANSON COUNTY:

THAT THE THREE DISTRICTS FROM WHICH THE MEMBERS TO THE BOARD OF COUNTY COMMISSIONERS ARE ELECTED SHALL BE COMPRISED OF THE FOLLOWING AREAS AND LOCALITIES:

1. FIRST DISTRICT: Spring Lake Township, Edgerton Township, Pleasant Township, Taylor Township, and the City of Emery; and the town of Farmer;

2. SECOND DISTRICT: Wayne Township, Buelah Township, and the City of Alexandria; and

3. THIRD DISTRICT: Plano Township, Hanson Township, Rosedale Township, Worthin Township, Fairview Township, Jasper Township, and the Town of Fulton.
