HANSON COUNTY COMMISSIONERS MINUTES OF PROCEEDINGS Tuesday, January 18, 2022

Chairman Kjetland with members Bumgardner, Fox, Schoenrock and Waldera present, called the regular meeting of the Hanson County Board of Commissioners to order on Tuesday, January 18, 2022.

No conflict of interest.

Motion Waldera, seconded by Fox to approve the agenda. Motion carried.

Motion Schoenrock, seconded by Fox to approve the January 4th meeting minutes. Motion carried.

Clerk of Courts fees collected for the month of December 2021 totaled \$3,493.84.

No citizens input.

Justin Friese, Hwy Superintendent, presented quotes from Hollaway Construction to repair a bridge east of Alexandria and a bridge north of Alexandria to get an estimated project cost.

As the frame is also bad on the gravel truck, a 5th wheel plate will not be added. The truck will possibly be sold and replaced with something different.

The JD Motor grader settling problem has been repaired and Justin has obtained certification to train new employees in need of a CDL, and possibly others in conjunction with any new County employee training, for the CDL regulations taking effect February 7, 2022.

Chad Pearson was unable to make today's scheduled agenda item.

Brandon Wingert, Sheriff, discussed the City Policing contracts and the Board decided that the \$2,000.00 monthly price set last year will remain.

Wingert gave a 2021 Sheriff's office update reporting 528 calls for service and 146 set of civil papers served. Vehicle and employee updates were also given.

Thank you to McCook County for donating an unused cage to the Sheriff's office saving Hanson County approximately \$1,100.00.

Wingert also gave an update for the Emergency Management office on upcoming trainings and meetings with the regional coordinator. Hazardous Mitigation money is available along with grants for Homeland Security equipment.

Hanson County will be receiving from the State, at home, Covid-19 test kits to be distributed to employees and the public. Further information will be announced on how to obtain the kits once the County has received them.

To have the ability to do tire repairs in-house by County employees, a motion by Waldera, seconded by Schoenrock to purchase a tire balancer and changer. Roll call: Waldera,

aye; Bumgardner, aye; Schoenrock, aye; Fox, nay. Motion carried. The approximate cost of \$6,000.00 will be split between the Sheriff and Hwy dept. budgets.

The Commissioners convened as the Weed Board. Vince Kayser, Weed Supervisor and Dave Klingberg, Farm Service Agency, were also present. Dave explained the FSA involvement in controlling weeds in CRP acres. Dave invited Hanson County to sign a memorandum of understand with Farm Service to work together to enforce controlling noxious weeds on these acres. The MOU was signed by both Klingberg and the Weed Supervisor, Vince Kayser.

Motion Bumgardner, seconded by Waldera to approve and authorize the Chairman to sign the three-year contract with Interstate Power Systems for the annual inspection of the Courthouse and EM generators. All voted aye, motion carried.

Motion Waldera, seconded by Schoenrock to approve and authorize the Chairman to sign the FY22 WIC amendment. All voted aye, motion carried.

Christi Pierson, Zoning Administrator and Jim Davies, States Attorney, joined the meeting to discuss adding a section to the zoning ordinance to regulate mining in Hanson County. The Zoning Board will draft the new section which will then be referred to the Commissioners for approval.

Motion Schoenrock, seconded by Fox to approve and authorize the Chairman to sign the Intergovernmental Contract with SDPAA. All voted aye, motion carried.

Taxpayer concerns with commissioner absenteeism was discussed. Reasons for being absent will be included in the minutes and the possibility of changing a meeting date if a commissioner is unable to attend.

No Commissioner/Board reports were given.
