MINUTES OF PROCEEDINGS
Tuesday, September 19, 2023

Chairman Fox called the meeting of the Hanson County Drainage Board to order on Tuesday, September 19, 2023 with members Bumgardner, Kjetland, Schoenrock and Waldera present.

Motion Bumgardner, seconded by Waldera to approve the agenda. Motion carried.

Motion Waldera, seconded by Schoenrock to approve the September 5th meeting minutes. Motion carried.

Travis Kampshoff, City of Emery, presented the completed application for the city's storm sewer project. Motion Waldera, seconded by Kjetland to approve permit #23-24 for the City of Emery pending the completion of the drainage checklist. All voted aye, motion carried.

After reviewing the permit and checklist attached, a motion by Bumgardner, seconded by Schoenrock to approve permit #23-25 and #23-26 for Cody Gronsten to tile in the NW4 6-102-58 and the SW4 31-103-58. Waldera abstained, all others voted aye, motion carried.

After reviewing the permit and checklist attached, a motion by Kjetland, seconded by Bumgardner to approve permit #23-27 for Beth Kayser to tile in the W2 of 20-102-57. All voted aye, motion carried.

Motion Waldera, seconded by Bumgardner to approve permit #23-28 for Beth Kayser to clean a vested drainage ditch in the E2 of 27-102-57. Motion carried.

Motion Kjetland, seconded by Schoenrock to approve permit #23-29 for Triple K Land to clean a vested drainage ditch in the NE4 of 34-102-57. Motion carried.

Motion Kjetland, seconded by Waldera to approve permit #23-30 for Justin Zeeb to clean a vested drainage ditch in the NW4 of 34-102-57. Motion carried.

After reviewing the permit and checklist attached, a motion by Kjetland, seconded by Schoenrock to approve permit #23-31 for Justin Zeeb to tile in the NW4 of 34-102-57. Waldera abstained, all others voted aye, motion carried.

Pending applicants' signature and a completed checklist, motion by Kjetland, seconded by Schoenrock to approve a joint permit for Bannwarth Ag and Millbrook Colony to tile in the SE4 of 24-104-59. Waldera abstained, all others voted aye, motion carried.

As there was no further business before the Board, a motion was made by Bumgardner, seconded by Waldera to adjourn the meeting. Motion carried.
